Watering and fertilization as necessary for the over-all health and appearance of the foliage using water machines or watering cans as appropriate.



Cosmetic care for plants includes dusting, cleaning, trimming, and pruning as needed.



Regular inspections for disease and pest infestation in the plants and treatment as necessary. Client will be provided with advance notice and MSDS sheets prior to application of any chemicals labeled for indoor use.



Monitoring environmental conditions such as light, temperature, and traffic patterns in the plant areas, including rotation of plant to light source as required for balanced growth.

Color rotation of bromeliads, orchids, greenery bowls, and succulents.

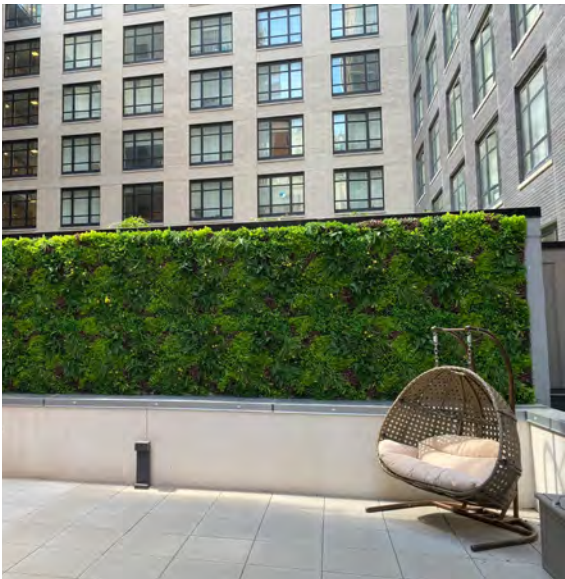
